There was some discussion on an all-wheat dinner for legislators at the next Session.

Elmer Sanderson expressed wishes of Dean Bently to be present but other matters prevented his being here. A discussion was held in regard to obtaining sedimentation equipment for State College. Motion carried.

Merlyn Jietz, Cook's Office Machines, Watertown was present to demonstrate the Underwood calculator. Moved by Borkirchert, seconded by Mason that the Underwood calculator be purchased for \$540.00. Motion carried.

The meeting of Great Plains Wheat Inc. board of directors meet on Nov. 28-29-30 in Denver, Colorado. This was discussed at length with all members of the commission except Bert Mason planning to attend. He said he may be able to arrange to attend but that he would fly by commercial airline. Arrangements were made with the State Aeronautics Commission to charter their Twin Bonanza and fly the other commission members and the director to this meeting.

Motion made by Mason, seconded by Brakke that South Dakota Wheat Commission join Great Plains Wheat, Inc. at the Denver meeting as a participating member if the basis of this participation was to the extent of \$20,000-\$22,000 as submitted in the 1961-52 budget for each state s membership. Motion carried.

Melvin Borkirchert did not have an answer to inquiries on the wheat abstract proposed, so this matter was tabled.

Clerical help for the commission office was discussed. Myrna Weber had been hired temporarily at \$2.00 per hour. Lynda Adams had also been hired temporarily at a salary of \$200 per month to try to expedite the backlog of correspondence that had accumulated prior to the opening of the office. Motion made by Covey, seconded by Borkirchert that the commission employ Lynda Adams for 30 days on a trial basis. Motion carried.

Director Tutsch informed the Commission that another steel desk and a Royal typewriter had been purchased through the Capitol Supply Room from the Banking Dept. for \$60.00.

The National Assoc. of Wheat Growers convention at Boise, Idaho on December 5, 6, 7 & 8 was discussed. Moved by Mason, seconded by Covey that Guiser, Brakke and Tutsch attend this meeting in the interests of S.D. wheat industry. Motion carried.

The KELO offer for television time was tabled temporarily, the cost being quite excessive and upon recommendation of other commissions who did not feel the cost was justifiable.

Bert Mason & Melvin Borkirchert were informed of the Dec. 4-5 meeting of South Dakota Farmers Elevators Association in Huron. Other members and the director of the commission would be in Boise, Idaho on these dates, so Mason & Borkirchert were going to make an effort to attend this meeting.

Members of the commission met briefly with directors of S.D.Wheat Producers Inc. Gil Young, Ralph Letellier, Ralph Lunder, Don Jorgensen, Ed Daum, Dennis Anderson being the representatives of the Wheat Producers.

SOUTH DAKOTA WHEAT COMMISSION Minutes of Meeting of December 19, 1961

The SDWC met Dec. 19, 1961 in the offices of said commission, 321 S. Pierre St., Pierre, South Dakota at 10:30 a.m. with Paul Guiser presiding and the following members present. Ernest Covey, Andrew Brakke, Melvin Borkirchert, Bert Mason, Ernest L. Johnson, and Dr. Orville G. Bentley. Ralph Cline, S.D. State College was also present.

Moved by Brakke seconded by Covey that minutes of Nov. 21, 1961 meeting be approved. Motion carried.

Sedimentation equipment purchased for State College use was discussed. The equipment and supplies will be located in the old dairy building. The plans are to operate the equipment on a cooperative basis to check test plots, growing and moisture conditions and variety comparisons within varieties. The indication was that a service chage will have to be made by State College to take care of help needed for running samples on sedimentation tests for purposes outside State College experiments. Ralph Cline indicated that, if possible, a demonstration of the sedimentation test will be carried on at district crop improvement shows.

The possibility of establishing a wheat quality laboratory at State College was discussed. Dean Bentley said he would check into the proposal and report at a later date.

The Jan. 9, 1962 Crop Quality Council sponsored meeting in Minneapclis at Leamington Hotel was discussed and it was agreed that Mason, Borkirchert, Covey and Tutsch make an attempt to attend this meeting if an invitation is extended.

Gary Enright of Garal Productions met with comission at 1:00 p.m. and outlined his proposals for a public relations program for one year which would include: 410 radio programs at a cost of \$1660; 858 news releases at a cost of \$945; a bi-monthly news letter to approximately 21,000 people—about 126,000 copies—at a cost of approximately \$1,330 plus postage and handling; publicity and public relations for the SDWC in the field of newspaper coverage—a total of 438 releases at a cost of \$890; proclamations of SD Wheat month with news release to 33 radio and television stations; news feature stories to 61 county seats and 12 daily newspapers plus photographs at a cost of \$425.

A question on travel expenses of ex-cfficio members was brought out and the director was instructed to obtain an Attorney General's opinion.

One proposal brought out was the possibility of establishing a grain handler's short course to improve the technique of buying grain and indirectly force the grain trade to demand cleaner handling facilities to meet specifications and as a result have quality wheat for market.

Moved by Borkirchert, seconded by Brakke that the following claims be allowed. Motion carried.

A letter received from Clifford Hope, Pres. of GPWI gave us the amount of \$11,086.50 as the maximum liability which would be incurred by South Dakota when it becomes a participating member on January 1, 1962. This is computed as follows:

Total budget of GPWI for 61-62 fiscal year \$389,000.00 Share of S.D. based on formula and by-laws,7.6% or 29,564.00

However, another provision of the by-laws is that a state for the first year is entitled to come in on the basis of 75% of the formula. 75% of \$29,564 equals \$22,173.00. For six months, Jan. 1, 1962 to July 1, 1962, the amount would be 50% of \$22,173.00, or \$11,086.50

This is the maximum amount which could be collected from South Dakota. GPWI office will bill us at the end of each month for our share of the expenses for that particular month. This will vary from month to month. If the entire budget is used up by the year's end, the total amount collected from South Dakota will be \$11,086.50. If Great Plains Wheat spends less than the budget, this amount will be reduced proportionately, based upon the amount actually expended.

South Dakota will be entitled to name two members to the <u>Board of Directors</u> and two members to the <u>Executive Committee</u> of GPWI. Under present structure these will be the same persons. Named to this were:

Paul Guiser - alternate Andrew Brakke
Ernest Covey - alternate Melvin Borkirchert

One member and one alternate for the <u>budget committee</u>:

Andrew Brakke - alternate Bert Mason

One member for <u>Transportation Committee</u>:

Bert Mason - alternate (to be designated by Chairman)

One member for Utilization & Domestic Marketing Committee:

Melvin Borkirchert - alternate (to be designated by Chairman)

The policy committee member will be selected by the Chairman of GPWI. These selections will be in effect only until July 1, 1962.

Attendance at the Hard Red Winter Wheat Workers Conference at the Nebraska Center for Continuing Education, U. of Neb., Lincoln, Neb. on Jan. 16,17,18 was discussed but action was deferred until a later date.

Motion made by Borkirchert, seconded by Brakke that meeting adjourn.
